## **Callander Pass HLF Landscape Partnership Bid**

On behalf of the Friends of Loch Lomond and The Trossachs, the independent conservation and heritage charity for the National Park, I am writing to confirm our full support for the Callander Pass HLF Landscape Partnership Bid.

We are pleased to see some of the themes of the proposed programme include the use of a variety of strong storytelling techniques as well as the development of some missing links in the local footpath network to enable visitors to enjoy and appreciate the special landscape setting of Callander and the Leny Pass.

We are also pleased to see improving access to the Leny waterfalls featuring in the programme as this is a key landscape asset that has been lost to visitors for years due to inadequate access arrangements and the lack of a safe road crossing from the nearby Forestry Commission car park. This site has the potential to be a major visitor attraction provided there is a significant investment in the supporting infrastructure and in a way that enhances the enjoyment of visitors to a special landscape feature close to a busy tourist route.

The overall programme should help to strengthen the appeal of the Callander area as a visitor destination. In the past few decades the town has suffered a decline in tourism due to a variety of factors including increased competition and lack of investment in the town to cater for changing markets. There is an urgent need for investment and the creation and funding of a Callander Pass initiative should prove to be a great stimulus for collective action to address some of the existing shortcomings and help to place Callander back firmly on the tourist map as a 'must see/must visit destination'.

The Callander area has a rich variety of natural and cultural heritage assets and we consider this programme provides an opportunity to enhance the presentation of the area in ways that encourage people to visit and learn more about what the area has to offer with economic spin-off benefits.

The programme also offers opportunities for people to learn new skills and to get involved in their local environment, ensuring that it will be improved and maintained for current and future generations.
